TIOGA COUNTY FAIR
August 10-15, 2009

1. RESERVATIONS — If you do not return the reservation form you will not be guaranteed a space.
2. NO TABLES, CHAIRS, or ELECTRICAL CORDS will be furnished. Cords must be of ample size for draw being used. **All water hook-ups must be equipped with anti-siphon valves.**
3. All exhibitors are to furnish own locks.
4. PLEASE, leave your exhibit area clean. Dumpsters are provided.
5. NO SMOKING is allowed in any Fair buildings or tents.
6. NO DOGS will be allowed on the grounds, except those part of an exhibit, scheduled entertainment, or to aid the handicapped. (All dogs must have a current vaccination for rabies.)
7. All sales and promotions must be conducted from your space. Roaming the grounds to sell or hand out materials is not allowed.
8. Ice will be available on the grounds beginning Sunday, August 9, 2009.
9. VEHICLES — Concessionaires vehicles will be permitted on the grounds to service exhibits until 10:00 a.m. daily, after which time they must be in the assigned parking area. **IMPROPERLY PARKED VEHICLES WILL BE TOWED AT THE OWNERS EXPENSE.**
Vehicles will not be occupied over night.
10. NO ALCOHOLIC BEVERAGES will be allowed on the grounds.
11. Food vendors must bring and display their current license.
12. Exhibit spaces must be cleaned before leaving.
13. No ATV's, golf carts, etc., unless approved by the Fair.
14. The fair reserves the right to prohibit the sale of any objectionable articles.
15. NOTE: INSURANCE REQUIREMENTS — NO EXCEPTIONS!!
A CERTIFICATE OF INSURANCE for general liability from your company is required. The certificate must name the Tioga County Fair as an additional insured and **MUST HAVE AN EXPIRATION DATE AFTER THE FAIR.** Coverage must be \$1,000,000 each occurrence and same for aggregate. The certificate must be an original, not a copy, and signed by the representative. If you do not have insurance, it may be **PURCHASED AS AN ENDORSEMENT ON THE FAIR POLICY** for \$90 plus \$5 handling fee. **IF A CERTIFICATE HAS NOT BEEN PRESENTED BY OPENING OF THE FAIR (3:00 P.M., AUG. 10, 2009) ENDORSEMENT WILL BE MADE TO THE FAIR POLICY AT THE ABOVE RATE.**
16. NOTE: TAX REQUIREMENTS!!
“ACT 62 OF 1992 ENACTED IN JULY OF 1992 REQUIRES THAT PURVEYORS ARE REQUIRED TO OBTAIN A LICENSE OR PERMIT FROM THE COMMONWEALTH OF PENNSYLVANIA TO SHOW EVIDENCE OF A PENNSYLVANIA SALES AND USE TAX LICENSE OR EXEMPTION CERTIFICATE.”
